This schedule is published pursuant to R.C. Section 2937.011. <u>The Court will establish bond for felony offenses on a case-by-case basis at arraignment.</u>

For all misdemeanor offenses for which there are currently no specific bonds provided by Court schedule, bonds shall be as follows:
